## B. In-Season Non-Cadet Grooming

#### 1. General

 a. NCSA will ensure their hair style haircuts or hair styles used, color used must appe

- an extreme appearance. Use of hair products that produce an oily or greasy appearance will not be used.
- b. Fingernails will be kept clean and neatly trimmed so as not to interfere with the performance or present a safety hazard. Only clear nail polish is authorized. Females will not exceed a nail length of ¼ inch, as measured from the tip of the finger. Males will keep nails trimmed so as not to extend beyond the fingertip.
- c. The face will be clean-shaven. If appropriate medical authority prescribes beard growth, the length required for medical treatment will also be specified. For example, "a neatly trimmed beard is authorized. The length will not exceed ¼ inch."

## 2. Male Haircut Requirements

- a. The hair on top of the head will be neatly groomed. The length and bulk of the hair will not exceed three inches, present a ragged, unkempt, or extreme appearance. Hair will present a tapered appearance and when combed will not fall over the ears or eyebrows. The hair at the back of the head will be tapered and not blocked. In all cases the bulk or length of the hair will not interfere with the proper wearing of athletic equipment.
- b. Sideburns will be neatly trimmed. The base will not be flared and will be a cleanshaven horizontal line. Sideburns will not extend below the middle of the ear canal.
- c. Faddish haircuts (such as Horseshoes" and "Teardrop") are not authorized. Males are not authorized to wear braids, cornrows, twists or dreadlocks.
